Deadline to submit materials – May 1, 2017.

As the result of the Conference **the scientific digest of reports** will be published.

The articles will be published in the scientific journal 'Economic Horizons'.

To find the requirements to the essential elements of the articles you can follow the address.

Requirements to the conference reports are as following:

Text of the report – no more than 5 pages A-4 format MS Word. Fields: all - 20 mm, Font: Times New Roman, size – 14, intervals – 1.5. The title of the papers is in bold, capital letters, centered. First Author Name and Surname, Scientific degree, and position, Affiliation (Organization) are written after the title on the right. To set a formula, diagrams, and tables use utilities in Word.

To create Reference list use the State Standard Bibliographic Description. The articles and conference reports should be edited, authors are responsible for the contents of manuscripts.

Manuscripts that do not meet the requirements, sent without the money order or sent after the deadline will not be considered.

Financial terms:

1. Travel expenses (travel, accommodation, meals, etc.) are paid by the participants own expense or at the expense of the member that sends them.
2. The cost of publication for participants from Ukraine is UAH 30 per 1 printed page.
3. For the direct participation in the conference, the registration fee must be paid (the information as for the rate of registration fee will be sent additionally).
